Eligible Breeds & Registry

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets, and Provisional breeds may be entered. Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA. This is a sighthound only event.

Stakes Offered

OPEN- Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

FIELD CHAMPION - Any ASFA Field Champion.

VETERAN - Any eligible sighthound that has met certification requirements whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years and Ibizans, Afghans, Rhodesian Ridgebacks, Salukis, and Whippets, whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

PROVISIONAL - Any eligible sighthound of a provisional breed that has met certification requirements. Not eligible for Best of Breed or Best in Field. **SINGLES** - Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

BEST IN FIELD WILL BE OFFERED BOTH DAYS

Special Trophies and Awards for Salukis:

In conjunction with SLASH's trials on October 19-20, 2024, the ASA (American Saluki Association) will be offering the ASA Brahma II Cup and the North Central Regional trophy for Salukis only.

To claim the trophy, the winning Saluki must be owned by an ASA member.

Other Information

- •All entries must be one year of age or over on the day of the trial. •Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. •Bitches in season, hounds with breed disqualifications, and lame hounds will be excused. •Hounds not present at roll call will be scratched.
- •Monorchid, cryptorchid, spayed, or neutered hounds may be entered. •All hounds will run twice, in trios if possible or braces (except in the Singles Stake), unless excused, dismissed or disqualified. •Muzzles are not required; it is the responsibility of the owner to determine if their hound needs to be muzzled.
- •Hounds with breed disqualifications are not eligible to enter except in the Singles Stake. •Lure machine is battery powered, continuous loop. Back-up equipment is available. •Lure will consist of highly visible plastic strips. •A fee of \$40 will be assessed for any returned checks. •There will be a \$5 fine for any loose hounds on the field that is not part of the course in progress. •There will be a \$15 fine for any owner/handler who does not clean up after their hound. •Substitutions for hounds already entered are allowed up 30 minutes prior to roll call on day of trial.
- *Hound certification runs will be offered Saturday only following trial, pending condition of the equipment and weather.
- *Persons exhibiting conduct detrimental to ASFA/SLASH/any hound(s) /other person(s) will be asked to leave the trial site.

Food

There will be *NO* food offered for lunch on either Saturday or Sunday. Bring your own snacks and beverages. There are *NO* nearby restaurants, so please plan accordingly. See separate page for information on Saturday after trial meal being provided at no charge.

Event Parking

Parking will be along two sides of the field, NO shade. Water will be available at a distance, bring your own shade and water for your hounds.

Site Information

The field IS fully fenced with gently rolling ground. No running water available, there is a pond for cooling off dogs, there is no shade. Bring your own water and shade for your hounds. Porta-John on site.


Keep dogs on lead even before/after trial as there are goats, cows and dogs in fenced paddocks on the property. Please be respectful of the animals and do not let your dogs antagonize them.

Note: the animals ARE at a distance from the coursing field and do not cause a distraction for dogs coursing.


Owner/handlers (under the age of eighteen years) must be signed/co-signed by a parent or guardian. Substitutes for lame or in-season hounds are allowed if the substitute has the same owner and the Field Secretary is notified at least one hour prior to roll call.

Any entry marked "First Time Entry" must be accompanied by a completed ASFA hound certification form or an AKC QC certificate (not required for entries in the Singles Stake). A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry (not required for first time entered NGA hounds).

The course will be reversed for the finals, runoffs and Best of Breed.

The Members of SLASH reserve the right to alter the course plans as required by weather, terrain and/or field conditions on the date of the trial.

There will be a \$5.00 fine assessed for any loose hound not participating in the course.

Plan on bringing your own food and snacks for lunch. Depending on size of trial and weather, we may not break for lunch each day.



Hound Certification Runs and Practice

Certification: Any entry marked *First Time Entered*, other than those entered in the Singles Stake, must present a completed ASFA hound certification form or an AKC QC certificate to the Field Trial Secretary BEFORE entries close. See the back of the entry form for certification forms and make extra copies if necessary. A photocopy of an acceptable registry must be submitted with a hound's first ASFA field trial entry. This requirement is waived for hounds registered with the National Greyhound Association.

Certification runs will be offered at the cost of \$5.00 per run on Saturday **only** after the completion of the Saturday trial. It is the responsibility of the entrant to find another hound of the same breed or similar running style to run with his/her hound for the certification. A sign-up sheet will be available on the day of the trial.

Current SLASH members may certify their hounds at no cost.

Practice: Practice will be scheduled after the certifications, on Saturday **only** time, equipment, and weather permitting.

Practice runs are \$5.00 for non-members. Free for SLASH members.

From 1-57 North bound or I-64 East bound: GPS will NOT take you to the address above from these routes! Take Exit 103 / Dix off of I-57. Go East approx. 1 mile to Stop Sign. Turn North and go 2-1/2 miles to Baseline/Walnut Hill Rd. Turn East and go 2 miles to Lopez Ln./Jefferson St. Turn South and go STRAIGHT for approx 1/2 mile to first set of double black gates on East.
